READ PRIOR TO **COMPLETION**

1. THE APPLICATION BEGINS WITH "LAST NAME". DO **NOT** FILL IN NYSID NUMBER, LICENSE NUMBER DATE OF ISSUE OR EXPIRATION DATE.
2. ALL ARESTS, INCLUDING DWI OR DWAI, MUST BE LISTED. FAILURE TO DO SO MAY RESULT IN YOUR ARREST FOR FILING A FALSE INSTRUMENT.
3. **FOUR FULTON COUNTY RESIDENTS** ARE NEEDED TO SIGN ALL THREE APPLICATION FORMS (NO RELATIVES). STREET **AND** MAILING ADDRESSES ARE REQUIRED FOR EACH REFERENCE..
4. 3 PICTURES, NO LARGER THAN 1 1/2" X 1 1/2" ARE NEEDED. PICTURES MUST BE ON PHOTO QUALITY PAPER. THIS OFFICE WILL AFFIX THEM TO THE APPLICATIONS.
5. **APPLICATION FEE IS \$116.00 –ONLY CASH OR MONEY ORDER IS ACCEPTED. PLEASE BRING EXACT AMOUNT.**
6. UPON COMPLETION OF THE APPLICATION FORMS, RETURN THEM TO THE CIVIL OFFICE FOR REVIEW. **DO NOT SIGN THE APPLICATION PRIOR TO SUBMISSION.**
7. YOU ARE REQUIRED TO ATTEND A PISTOL SAFETY TRAINING COURSE. AN APPOINTMENT WILL BE SCHEDULED FOR THE COURSE WHEN YOU COME IN TO BE FINGERPRINTED.
8. **CALL WITH ANY QUESTIONS!!!!**
9. **APPLICATION WILL NOT BE ACCEPTED IF COMPLETED INCORRECTLY.**

Your pistol license specifically states: "Have you ever been arrested or indicted anywhere for any offense, including DWI (except traffic infractions)?" You **must** state **ANY AND ALL ARRESTS, INCLUDING SEALED ARRESTS, YOUTHFUL OFFENDERS, ACOD'S AND DISMISSALS** whether or not you were convicted. Failure to do so may result in an arrest for filing a false instrument. An investigation will take place to verify the information provided.

FULTON COUNTY PISTOL PERMIT APPLICANTS

IMPORTANT INFORMATION PLEASE READ BEFORE YOU APPLY

1. The decision on whether you are granted a pistol permit will be made by the licensing officers, which in Fulton County are the two County Court Judges, not the Sheriff's Department.
2. Before you spend money on the application process, currently \$116.00, there are several items that may disqualify you from receiving a pistol permit.
3. Under New York State law it is in the sole discretion of the licensing officer as to whether or not to grant a person pistol permit privileges.
4. The basic requirements are as follows(this is a partial list):
 - a. at least 21 years old or older, unless honorably discharged from military service under 21;
 - b. of good moral character;
 - c. not convicted anywhere of a felony or serious offense (defined in Penal Law 265.00(17)). misdemeanors including: sex offenses, illegal possession of weapons, drug offenses, possession of burglars tools, escape, stalking, contempt, endangering the welfare of a child, a variety of domestic violence crimes among others;
 - d. not suffering now or in the past from any mental illness, or previously confined in a facility for mental illness, required to disclose;
 - e. not currently under a suspension of pistol permit privileges due to Family or Criminal Court order of protection.
5. A Judge may deny a permit if the applicant fails to disclose any of the information as required on the application.

6. **The failure to disclose any arrests, summons, charges, indictments, anywhere for any offense including DWI. For purposes of a pistol permit it is the both the ARREST and the DISPOSITION or outcome of the case that must be reported. Youthful Offender, ACOD's, and dismissals must be disclosed.**

**FAILURE TO DISCLOSE INFORMATION IN #6 MAY
AUTOMATICALLY DISQUALIFY A PERSON FROM
RECEIVING A PISTOL PERMIT.**

7. **The general types of licenses, not all inclusive, are as follows:**
 1. **Possess on premises;**
 2. **Possess or carry during employment;**
 3. **Carry concealed, subject to restrictions also known as for sporting purposes, hunting, fishing and target, see #8;**
 4. **Carry concealed, also known as unrestricted if good cause exists, as determined by the Judge who issues your permit;**
 5. **Possess antique operable pistols;**
8. **All permits are subject to restrictions as determined by the individual Judge and may include limited to hunting, fishing, target practice, competition shooting, and others.**
9. **There are certain automatic reasons to revoke or suspend a person's pistol permit privileges, including domestic violence incidents, felonies, sex offenses, furthermore a Judge may revoke a firearms license at any time for "any good reason". The suspension or revocation of pistol permit privileges is solely in the discretion of the Judge.**
