Pledge of Allegiance

Councilman Becker made a motion to accept the minutes from the last meeting. It was seconded by Councilman Smith and approved; In Favor: 4 Opposed: 0

Clerk Report:

In June the Town took in \$227.12; \$18 in Dog Licenses, \$90 in Transfer Station permits, \$69.12 in Building Permits, \$40 for a Marriage License, and \$10 in Certified Copies. It was disbursed; \$22.50 to the New York State Health Department, and \$227.12 to the Supervisor.

Code Enforcement:

John Furlong reported 5 inspections, 3 new issued permits, 1 Certificate of Occupancy, and attended 4 hours of in-service training in Albany.

Dog Control:

Pat Ashbey reported one dog neglect or abuse case turned over to the Sheriff's Department, dog sent to the Vet.

The Supervisor, Bookkeeper, and Assessor's reports were submitted.

Highway, Building, and Grounds:

Paul Brink reported that the Ford F550 is not done yet, but the work is under warranty. Soil and Conservation has grant money to spend on stabilizing banks on waterways and asked if we need any work done. The Town would only be responsible for trucking. Paul talked to John Persch and told him that he needs to come to the Board for this. He also said that they have two years to use the money.

The 2009 Plow Truck will go back on the auction site next week with a lower reserve of \$40,000.

RESOLUTION #35-19 Contract for Tower Road Maintenance

Councilman Smith offered the following Resolution and asked for its' approval:

Whereas, the County Highway Department is responsible for plowing and sanding the road leading to the Fulton County Communications Tower to provide access during the winter months: said road being approximately .80 miles long; and

Whereas, the Town of Bleecker already plows the road connecting to the County's portion of said road; now therefore be it

Resolved; that the Bleecker Town Board authorizes a contract to be signed to provide maintenance by the Bleecker Highway Department on the Tower Road leading to the Communications Tower during the winter months at a cost not to exceed \$4,000 (pro-rated from \$5,000 per mile).

Whereas, the County Superintendant of Highways & Facilities of Fulton County has submitted a contract for the removal of snow and ice control from certain designated County Roads within the Town of Bleecker under Section 135A of the Highway Law, now be it therefore

Resolved, that pursuant to Section 135A of the Highway Law, the Bleecker Town Board does hereby accept the contract for snow removal and ice control as submitted and authorizes the Supervisor and Town Board to execute the contract.

RESOLUTION #37-19 Agreement to Spend Highway Funds

Councilman Smith offered the following Resolution and asked for its' approval:

Pursuant to the provisions of Section 284 of the Highway Law, it is hereby **Resolved,** that the Bleecker Town Board agrees that moneys levied and collected for the repair and improvement of highways, and received from the State for the repair and improvement of highways, shall be expended as follows:

- **General Repairs.** The sum of \$92,885.48 may be expended for general repairs upon 28.23 miles of Town highways, including sluices, culverts, and bridges having a span of less than five feet and boardwalks or the renewals thereof.
- **Improvements.** The following sums shall be set aside to be expended for the improvement of Town highways:
 - (a) On the road commencing at 258 Lily Lake Rd and leading to 415 Lily Lake Rd., a distance of 3,700 ft, there shall be expended not over the sum of \$92,885.48 Type: Cold Mix Paving Width of traveled surface: 18'

Thickness: 4" Subbase: Gravel

(b) On the road commencing at Co Hwy 125 and leading to 502 Barlow Rd, a distance of 6,200 ft, there shall be expended not over the sum of \$92,885.48.

Type: Single Chip Sealing Width of traveled surface: 18' Thickness: ½ " Subbase: Cold Mix Paving
