Pledge of Allegiance

Clerk Report:

In October the Town took in \$ 70; \$20 in Dog Licenses, \$20 in Transfer Station Permits, and \$30 in Building Permits. It was all given to the Supervisor.

Code Enforcement:

John Furlong reported 3 inspections, 2 new permits, and one Certificate of Compliance.

Pat Ashbey reported no activity.

Highway, Building and Grounds:

Paul Brink reported that the highest bid on the 2009 plow truck was \$20,000. He asked if we should put in a counter bid or hold on to the truck for another month and try again. It was decided to contact the Town of Roseboom and see if they are still willing to buy it at \$27,500, and, if not, set a minimum bid of \$25,000.
