TOWN OF BLEECKER REGULAR MONTHLY MEETING FEBRUARY 19, 2020

The meeting was called to order at 7:00 Councilman Becker: Present Councilman Winnie: Present Supervisor Howard: Present Councilman Bartholomew: Present Councilman Smith: present Also in attendance were Richard Didomizio, John Furlong, and Paul Brink

Councilman Becker made a motion to accept the minutes from the last meeting. It was seconded by Councilman Smith and approved; In Favor: 5 Opposed: 0

John Furlong addressed the Board concerning new State procedures. He asked that the Town furnish a computer and printer for Code Enforcement since the State will no longer issue books for Building Codes. All will now be available online only. The computer would also need software to access the Code, as it is run by a private company under contract to the State. He also asked if the Code Enforcement department could have money budgeted to pay for schooling instead of the voucher system as it is causing financial hardship. Supervisor Howard asked him to set up a meeting to discuss what he needs, and the Board will provide it for him. Mr. Furlong also asked that we look into passing a Local Law to address violations specifically and institute penalties for them. Right now we cannot enforce any code violations because we have no laws in place.

Clerk Report:

In January the Town took in \$462: \$15 in Dog Licenses, \$350 in Transfer Station permits, \$72 in Building Permits, and \$25 for a Games of Chance license. It was all given to the Supervisor.

Code Enforcement:

John Furlong reported one inspection, one Certificate of Compliance, and he attended an in-service training in Albany.

Dog Control: No Activity

The Assessor, Supervisor, and Bookkeeper's reports were submitted. Supervisor Howard told the Board that Larry Doubleday is resigning from the Board of Assessment Review and moving out of the area. We will need to find someone to serve.

Highway, Building, and Grounds:

Paul Brink told the Board that the price for a new plow truck is the same as last April's bid, therefore we can go ahead and order the new truck.

RESOLUTION #20-20 Authorization to Buy 2021 Plow Truck

Councilman Becker offered the following Resolution and asked for its' approval:

Resolved; the Bleecker Town Board hereby authorizes the Highway Superintendant to order a 2021 International plow truck for the price of \$190,814.65.

RESOLUTION #21-20 Approve Contract for Pinnacle Bridge Repair

Councilman Winnie offered the following Resolution and asked for its' approval:

Resolved; the Bleecker Town Board does hereby approve a contract with R&B Construction for the repair of Pinnacle Road bridge in the amount of \$22,714.

The repair should last 5 years, and we should expect to replace the bridge by then.

May 1st, 2nd, and 3rd will be Dumpster Days Paul Brink also told the Board that he is working on fuel logs for the trucks.

The State Troopers have asked that the Town provide a lock-box for tickets and Court papers since the new laws for speedy trials have gone into effect. They need to get papers to us much sooner, and there is not always someone available for them.

RESOLUTION #22-20 Authorization to Buy a Lock-Box for the Town Hall

Resolved; the Bleecker Town Board does hereby authorize the Clerk to order a lock-box for the Town Hall, for the purpose of receiving Court papers in off hours.
