Pledge of Allegiance

Clerk Report:

In September the Town took in \$135; \$25 in dog licenses, \$50 in Transfer Station permits, and \$10 in Building permits. It was all given to the Supervisor.

Code Enforcement:

John did a 3 day training course and performed 3 inspections.

Dog Control:

Pat Ashbey reported one dog bite, the dog was quarentined for 10 days and released.

The Supervisor, Bookkeeper, and Assessor's reports were submitted.

Highway, Building, and Grounds:

Paul Brink reported that the bridge inspections have been done, the only problems were debris on Pinnacle Road and guard rails on Tannery Road that need to be fixed. Paving and shoulder work have been completed on South Shore Road.The Town of Johnstown finished their end of the road, too.

Councilman Bartholomew asked if we had gotten an answer on coming up with a junk law. Supervisor Howard said that the attorney thought that our existing littering law would suffice, and that we can work within that. Councilman Smith said that there seems to be a need for some sort of blight law. Supervisor Howard said that it was up to the Board, but we have to be careful because it has to be enforced across the board, not individually.
