Public Comment:

Clerk Report:

John Furlong did 7 inspections, issued 6 new permits (1 alteration, 2 single family homes, 1 garage, 1, porch, and 1 pole barn) and completed 3 hours of on-line training.

Dog Control:

Pat Ashbey reported two calls for nuisance dogs. Both were issued warnings.

Highway, Building, and Grounds:

Paul Brink reported that prep work is being done on the Pinnacle Road.

Councilman Bartholomew said that he was in contact with the County Highway Superintendant, and that Mr. Yost has received the paperwork for a traffic study on North Shore Road, and that he will be sending it in to DOT.
