## Clerk Report:

In August the Town took in \$156.80; \$60 in Transfer Station permits, and \$96.80 in Building Permits. It was all given to the Supervisor.

#### Code Enforcement:

John Furlong performed 4 inspections, issued 7 Certificates of Compliance, and 1 new permit for an alteration.

### Dog Control:

Pat Ashbey reported 1 dog bite, animal quarantined, and 1 stray that could not be found.

The Supervisor, Bookkeeper, and Assessor's reports were submitted. The Assessor has been out for medical reasons, so he will be in the office Friday to make up time.

The Town's insurance renewal will show an increase of \$1590, and our agent is advising that we add a Cyber Security rider for \$645.70, that will provide \$250,000 in coverage. That will bring our premiums up to \$16436 +\$645.70. We will need to formalize a cyber policy and have it ready for the Organizational Meeting next year.
