#### Highway, Building, and Grounds:

Jeff Brooks has added new computerized reports for the Highway Department documenting maintenance on each road. There will now be a record of where maintenance was done and when.

The Town is looking at buying new 550 trucks with wings to replace the big trucks. Jeff Brooks asked if he should get bids on this? The Board decided to have Mr. Brooks do some research and bring it back to the Board. Councilman Croucher said that he would like to see where these are going to be used.
