Councilman Becker asked Councilman Croucher what he thought his authority over the Highway Department consisted of. Councilman Becker received a report that Councilman Croucher had authorized the paving contractor to park on private property. Councilman Croucher replied that he had not spoken to the contractor.

Supervisor Howard asked that budget line 5110.4 Maint. Of Streets exp other be decreased to 10,000. It is thew line that covers culverts and materials not supplied by our pit. Since there is more material than thought, we can safely reduce the budget line.

County, Town and Fire Tax totals for 2025 should all be lower than last year's totals. Highway is budgeted for all the men getting the maximum per hour, in case they get their CDL's and move up.

Windows for the Highway Garage and the coating for the Quonset hut will be bought out of this year's budget. Windows have already been ordered.

Jeff Brooks reported that the State DOT has flagged the Pinnacle Bridge, so he has contacted Andy Bell. An estimate for repairs will be ready next week.
